- 2. Please clearly tick mark the position being contested and no member may contest for two positions at the same elections.
- 3. Each candidate shall be entitled to be nominated by one nomination paper only. Please deliver the Nomination Paper personally to the Alumni Office in person or through a representative at the address given below and ensure that you collect the receipt. Last date of receipt of nomination at the Alumni Office is 1400hr on 21 Oct 2025.
- 4. Before filing the nomination please clear all dues towards the SJA AA and sign the declaration to this effect. In case the declaration is found to be false at a later date your candidature shall be dismissed.
- 5. All candidates will submit a written disclosure of their business dealings with the school if any along with the nomination papers on a plain paper duly signed.
- 6. List of all nominations received by the Returning Officer, post wise shall be published on SJA AA website and displayed in the SJA AA office.
- 7. All nominations will be scrutinised by the Election Committee with the help of MC and in the event of any information being found false or incomplete or not satisfying the qualification criteria, the nomination shall be cancelled and informed to the candidate by 28 Oct 2025.
- 8. Provisional list of all eligible candidates will be published on the SJA AA website on 28 Oct 2025. A letter of acceptance of nomination shall be emailed to the candidates. Last date of withdrawal of candidature is 30 Oct 2025. A written notice to this effect will be served to the Returning Officer by the candidate in writing by physical letter/e-mail (from the registered email address only) in the prescribed form available on SJA AA website. Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- 9. Final list of all candidates will be published on the SJA AA website within a day of finalisation of the list of candidates i.e. **31 Oct 2025.**
- 10. You may obtain details of members (*voters*) to include postal address, telephone No and email address after paying a fee of Rs 1,000/- (Rupees One Thousand Only) after your candidature has been accepted. (This list shall not be used for any other purpose or circulated by the candidate.)
