1. The Last date for FILING of nominations is 27th October 2021.
2. The Last date for WITHDRAWAL of nomination/candidature is 6th November 2021.
3. The last date for updating contact details for remote e-voting shall be communicated on the website. Further, owing to restrictions imposed by COVID - 19 pandemic, there would be no on-site e-voting for the current election and only remote e-voting shall be done. The remote e-voting shall start 72 hours before the election day and end on the election day at specified time as may be fixed by the Returning Office and the MC.
4. As per the decision of the Management Committee Mr. Rajeev Nangia has been appointed as the Chief Returning Officer for the elections scheduled in December 2021.

As per the Bye-Laws of the Association, only those Josephites can contest who are bonafide members of the Alumni Association for a minimum period of One (1) year prior to the date of elections for the post of MC Member; Whereas for posts of President, VPs, Secretary and Treasurer every candidate should be a bonafide member of the Alumni Association for a minimum period of Two (2) years.
