- List of all nominations received by the Returning Officer, post wise shall be published on SJA AA website and displayed in the SJA AA office.
- All nominations will be scrutinised by the Election Committee with the help of MC and in the event of any information being found false or incomplete or not satisfying the qualification criteria, the nomination shall be cancelled and informed to the candidate by **03rd Nov 2021.**
- Provisional list of all eligible candidates will be published on the SJA AA website on **04th Nov 2021.** A letter of acceptance of nomination shall be emailed to the candidates. Last date of withdrawal of candidature is **6th Nov 2021.** A written notice to this effect will be served to the Returning Officer by the candidate in writing by physical letter/e-mail (*from the registered email address only*) in the prescribed form available on SJA AA website. Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- Final list of all candidates will be published on the SJA AA website within a day of finalisation of the list of candidates i.e. **07th Nov 2021.**
